### **HBYC Annual Membership Fee Rate Chart**

- 1. If you are a <u>current member of HBYC</u> and dock at SHM or dock offsite, your membership fee is: \$185.00 + \$12.49 (Ohio and Erie County Sales Tax) = **\$197.49**
- 2. If you are a **prospective member of HBYC**, your first-year fees as a new member <sup>(1)</sup> are determined as follows:
  - A. Whether you are a current docker at SHM or dock offsite when you apply for HBYC membership, your fee will consist of the New Membership Initiation fee of \$75, the Club House Assessment fee of \$150, Annual Dues of \$185, and Sales Tax of \$27.68 to equal: \$75 + \$150 + \$185 + \$27.68 = \$437.68 (3).
  - B. Whether you are a current docker at SHM or dock offsite <u>and you are a Veteran</u> (2) when you apply for HBYC membership, your fee will consist of a reduced New Membership Initiation fee of \$25, the Club House Assessment fee of \$150, Annual Dues of \$185, and Sales Tax of \$24.30 to equal: \$25 + \$150 + \$185 + \$24.30 = \$384.30 (3).
  - C. If you or your domestic partner are 40 years of age or under, dues are waived for the first year. Your fee will consist of the New Membership Initiation fee of \$75, the Club House Assessment fee of \$150, and Sales Tax of \$15.19 to equal: \$75 + \$150 + \$15.19 = \$240.19<sup>(3)</sup>.
  - D. If you or your domestic partner are 40 years of age or under <u>and that same person is a Veteran</u>, dues are waived for the first year and your initiation fee is reduced. Your fee will consist of the New Membership Initiation fee of \$25, the Club House Assessment fee of \$150, and Sales Tax of \$11.81 to equal: \$25 + \$150 + \$11.81 = \$186.81<sup>(3)</sup>.
    - 1) A membership year is defined as the period from 1 January to 31 December. A new member is a person(s) at any point in time within their first membership year as defined by these dates.
    - 2) The HBYC membership fee veteran discount is a first-year one-time only discount.
    - 3) New members, regardless of age, joining on or after 1 September of the current membership year will not be charged membership dues for the remainder of that year. However, the new member must still submit all initiation and assessment fees as described in Item 2(C) or 2(D). On 1 January of the following membership year, a new member is considered a current member and will pay annual dues compliant with Item 1 above.

Submit your membership application with cash or with a check written to HBYC or Harbor Bay Yacht Club for the proper amount as defined above. The mailing address is at the top of the application. The application and check may also be given to any member for delivery to the HBYC membership chair or any HBYC Bridge Officer.
